II. Call to Order	Chair Cara Meeks called the meeting to order, and asked everyone to go around and introduce themselves.
III. Review of	Cara asked for everyone to look over the minutes from the May meeting, and then asked for a formal approval.
Minutes	Kalen Degroat made a motion to approve, and it was seconded by Diane Toto.
IV. Old Business	A Synthetic Drug Update was done by Detective John Bergen of CCSO. It was an overview of K-2, Bathsalts,
Synthetic Drug	and other synthetic drugs being used through a powerpoint. Det. Bergen talked about the population using
Update	these drugs, and also the stores that are continuing to sell them, which is available on the website.
Letters/Social Security Office	Laura Nessola provided a short update on questions regarding why we have no Social Security office here in the county. She has been contacting Congressman Nugent's office and has posed the question to them as to why some counties have multiple locations and Citrus does not even have one office. Also, she spoke to Soc. Security concerning documentation and procedures and how it will take multiple trips for clients to receive their cards and finalize the process.
Subcommittee Development	Renea updated everyone that 2 subcommittees had been formed with local members of the community to serve on the Communication and Mental Health/Substance Abuse Committees for the Alliance. Judge Thomas is chairing the Communication, and Rick Bedson of DJJ is chairing the Mental Health/Substance Abuse. Cara shared that while we support 211 that there are still referral services that are not listed and that we are missing some of the communication links because of personal connections.

VI. New Business Refresh/Refocus News/Updates	From the August meeting it was discussed how important Customer Service. Renea told the group that she felt like it would be good to have an event to help folks unwind and be treated for a day – and that it would be a time to refresh themselves and refocus. It was decided that it would be good after Christmas to do this event. Renea is to look at options maybe with WTI as a possible location.
	It was decided additionally that the best time to do the Community Expo would also be in January or February. Renea also reminded people to submit information that they wanted on the website.
V. Roundtable	Spot Kids Club has scholarships, Mega Library Sale coming up. Thanksgiving Feeding Alliance is kicking off.
Discussion	Tri-County Human Trafficking Team needs forms filled out for service providers. Health Dept. – Storm Meeting on Tues. Sept. 17 <sup>th</sup> . LifeChoice Center is in need of housing. Daystar is seeing a lot of increase and need for services. DCF has new training methods and forums. The Centers has new programs, and better turnaround time. We Care has a lot of food going out. Boys/Girls Club – Summer was 3 times what we did last year – needs volunteers, scholarships. ELC—National Child Passenger Safety Week—Seat Check on 9/21—Crystal River Mall. ADC meeting on Sept. 12 <sup>th</sup> with SADD. Aspire received UW funding – for school programs. NCM—lots of food going out –free medical/dental – MOA being re-written. Faith Haven – Leadership training in addition Club Soquili—3 days a week. St. Leo—48 hour seminars – Human Trafficking seminars, response to lone shooters, courtroom 101. Youth and Family Alternatives – more money for 11 new counselors for all the counties, 3 in Citrus, to focus in on families. Hospice – taking applications for Camp Good Hope.
